DESCRIPTION:

Magellan Midstream Partners, LP, is a publicly traded partnership that transports oil, does not provide viewpoint protections for its employees. However, it has not publicly terminated business relationships based on views or beliefs. The company requires organizations abide by its nondiscrimination charitable giving policies but has not used its reputation or corporate funds for ideological causes. Magellan Midstream Partners, LP has not used its political contributions for ideological purposes. For these reasons, Magellan Midstream Partners, LP receives a Lower Risk rating.

Corporate Weaponization

Has denied service to customers, suppliers, or vendors due to their political views or religious Lower Risk beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries.

Magellan Midstream Partners, LP has not publicly fired customers, suppliers, or vendors based on political views or religious beliefs (1).

Charitable giving (including employee matching programs) policies or practices discriminate Medium Risk against charitable organizations based on views or religious beliefs.

Magellan Midstream Partners charitable giving guidelines require that organizations abide by its nondiscrimination policy, including on the basis of sexual orientation and gender identity, thereby excluding some religious charities (1).

Employment policies fail to protect against discrimination based on political affiliation/views and/or religion.

Magellan Midstream Partners, LP does not provide viewpoint protections for its employees (1)(2).

Uses corporate reputation to support ideological causes and/or organizations hostile to freedom
