DESCRIPTION:

Olin Corporation, a chemical manufacturer, vets international vendors according to LGBTQ policies and does not protect its employees against viewpoint discrimination. However, the company has not publicly terminated business relationships based on views or beliefs. Olin has not used its reputation or corporate funds for ideological purposes. The company has not used its political contributions for ideological purposes. For these reasons, Olin Corporation receives a Lower Risk rating.

Corporate Weaponization

Has denied service to customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries.

Medium Risk

Olin promotes divisive sex and gender policies. Its Code of Conduct requires international vendors to include sexual orientation and gender identity in their nondiscrimination policy [\(1\)](#). However, Olin has not publicly fired customers, suppliers, or vendors based on political views or religious beliefs.

Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs.

Lower Risk

Olin does not discriminate against charitable organizations based on views or beliefs [\(1\)](#).

Employment policies fail to protect against discrimination based on political affiliation/views and/or religion.

Olin does not provide viewpoint protections for its employees [\(1\)](#).

Uses corporate reputation to support ideological causes and/or organizations hostile to freedom of expression.

Olin has not supported ideological causes or policies [\(1\)](#).

Uses corporate funds to advance ideological causes, organizations, or policies hostile to freedom of expression. Lower Risk

Uses corporate political contributions for ideological, non-business purposes. Lower Risk
