## **DESCRIPTION:**

ICM has not publicly terminated business relationships based on views or beliefs. The company does not publish a nondiscrimination policy but does not discriminate against charitable organizations based on views or beliefs. ICM supports the Equality Act. The company opposed various state and local legislation intended to protect parental rights, girls' sports, bathroom facilities, and gendered spaces. ICM denounced various states' legislative efforts to protect election integrity and security. However, it has not used its corporate reputation or funds to advance ideological agendas. For these reasons, ICM receives a Lower Risk rating.
