## **DESCRIPTION:**

Spirit Airlines does not provide viewpoint protections for its employees but has not publicly terminated business relationships based on views or beliefs. Spirit Airlines offers unconscious bias, systemic racism, and allyship training to its employees. Spirit Airlines donated a total of \$250,000 to social justice-related organizations for the Black Lives Matter movement, and the list included various Urban League affiliates. However, it does not discriminate against charitable organizations based on views or beliefs and has not used its reputation for ideological purposes. For these reasons, Spirit Airlines receives a Lower Risk rating.

## **Corporate Weaponization**

Has denied service to customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries.

Spirit has not publicly fired customers, suppliers, or vendors based on political views or religious beliefs.
