DESCRIPTION:

Although Peraton does not provide viewpoint protections for its employees, it has not canceled contracts or fired employees for their views or beliefs. Peraton does vet vendors for LGBTQ policies and promotes LGBTQ messaging and advocacy. For these reasons, Peraton receives a Medium Risk rating.

Corporate Weaponization

Has denied service to customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries. **Medium Risk**

Peraton requires suppliers to provide sexual orientation and gender identity nondiscrimination protections (1)(2). Peraton has not publicly terminated existing business relationships due to viewpoints or beliefs.

Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs. **Lower Risk**

Peraton restricts its charitable giving to veteran affairs. It does not discriminate against religious organizations in its charitable giving (1).

Employment policies fail to protect against discrimination based on political affiliation/views and/or religion. **High Risk**

Peraton does not protect employees from viewpoint discrimination (1).

Corporate Governance and Public Policy

Uses corporate reputation to support ideological causes and/or organizations hostile to freedom of expression. **Medium Risk**

Peraton has published statements supporting ideological gender theory (1).

Uses corporate funds to advance ideological causes, organizations, or policies hostile to freedom of expression. Medium Risk

Peraton helped fund and was a partner of the Capital Pride Parade in 2022 (1). Peraton is a brass sponsor of Out and Equal, an LGBTQ organization (2)(3).

Uses corporate political contributions for ideological, non-business purposes.

Lower Risk

Peraton does not use its PAC donations for ideological purposes (1).
