Koch Industries has not publicly terminated business relationships based on views or beliefs. Some Koch subsidiaries vet vendors according to LGBTQ policies and do not provide employees with protections against viewpoint discrimination. Koch Industries does not use its reputation, corporate funds, or PAC contributions for ideological purposes. The company does not discriminate against religious organizations in its charitable giving. For these reasons, Koch Industries receives a Lower Risk rating.

Corporate Weaponization

Has denied service to customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries.

Medium Risk

Various Koch Industries subsidiaries, including Georgia-Pacific, require suppliers to provide sexual orientation and gender identity nondiscrimination protections (1). Koch Industries has not publicly fired customers, suppliers, or vendors based on political views or religious beliefs.

Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs.

Lower Risk

Koch Industries does not appear to discriminate against charitable organizations based on views or beliefs (1).

Employment policies fail to protect against discrimination based on political affiliation/views and/or religion.

Koch Industries does not provide viewpoint protections for its employees (1).
