Talbots, a retailer and designer, does not provide viewpoint protections for its employees. However, it has not publicly terminated business relationships based on views or beliefs. Talbots also partners with Dana-Farber Cancer Institute to honor its commitment to supporting women's health and wellness (1). Talbots does not have an employee matching program at this time (3).
