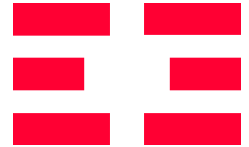




# Allegiant Airlines

## DESCRIPTION:

Allegiant Airlines is High Risk. The company yields to political activism in shaping corporate governance, potentially alienating consumers, dividing employees, and harming shareholders. The company implements race and identity-based policies that replace merit, excellence, and integrity with preferential treatment and outcomes. Allegiant Airlines embraces corporate initiatives that redirect its central focus from business goals to partisan policies and divisive issues. This approach fails to safeguard free exercise, free speech, and free enterprise.

## Corporate Weaponization

**Has canceled customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries.** **High Risk**

*In 2022, Allegiant Airlines removed a passenger from a flight for wearing a "Let's Go Brandon" face mask [\(1\)](#)[\(2\)](#)[\(3\)](#).*

**Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs.** **Lower Risk**

*Allegiant does not appear to discriminate against charitable organizations based on views or beliefs. The company's Corporate Giving program focuses on travel, community safety, and STEM [\(1\)](#).*

**Employment policies fail to protect against viewpoint or other discrimination and/or are ideological in nature.** **Medium Risk**

*Allegiant Airlines does not provide viewpoint protections for its employees [\(1\)](#). The company requires unconscious bias and diversity training for its employees [\(2\)](#).*
