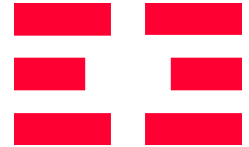




# Allegiant Airlines

**DESCRIPTION:**

In 2022, Allegiant Airlines forcibly removed a passenger from a flight for wearing a "Let's Go Brandon" mask. Allegiant Airlines does not provide viewpoint protections for its employees. However, the company has not publicly terminated business relationships based on views or beliefs. Allegiant Airlines requires unconscious bias training for employees and supports LGBTQ Pride and ESG within its business practices. For these reasons, Allegiant Airlines receives a High Risk rating.

## Corporate Weaponization

**Has canceled customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries. High Risk**

*In 2022, Allegiant Airlines removed a passenger from a flight for wearing a "Let's Go Brandon" face mask (1)(2)(3). Allegiant Airlines has not publicly canceled customers, suppliers, or vendors based on political views or religious beliefs (4).*

**Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs. Lower Risk**

*Allegiant does not appear to discriminate against charitable organizations based on views or beliefs. The company's Corporate Giving program focuses on travel, community safety, and STEM (1).*

**Employment policies fail to protect against viewpoint or other discrimination and/or are ideological in nature. High Risk**

*Allegiant Airlines does not provide viewpoint protections for its employees (1)(2).*

*Allegiant Airlines supports ESG within its business practices (1). It requires unconscious bias and diversity training for its employees (2). Allegiant Airlines supports LGBTQ Pride within its business (3).*

*Allegiant Airlines has not used corporate funds to advance ideological causes, organizations, or policies (1).*
