DESCRIPTION:

Aaron's does not yield to political activism in shaping corporate governance, preventing initiatives that potentially alienate consumers, divide employees, and harm shareholders. The company elevates merit, excellence, and integrity ahead of race and identity-based policies. Aaron's does not embrace corporate initiatives that redirect its central focus from business goals to partisan policies and divisive issues. This approach protects free exercise, free speech, and free enterprise.

Corporate Weaponization

Has canceled customers, suppliers, or vendors due to their political views or religious beliefs OR Lower Risk corporately boycotts, divests, or sanctions regions, people groups, or industries.

Aaron's LLC has not publicly canceled customers, suppliers, or vendors based on political views or religious beliefs (1).

Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs.

Lower Risk

Aaron's LLC does not discriminate against charitable organizations based on views or beliefs ($\underline{1}$). The company will only match donations to "nondenominational programs... such as a camp, community center, food pantry, or youth home," ($\underline{2}$).

Employment policies fail to protect against viewpoint or other discrimination and/or are ideological in nature.

Medium Risk

Aaron's LLC does not publish a nondiscrimination policy (1).

Corporate Governance and Public Policy

Uses corporate reputation to support causes, organizations, or policies hostile to freedom of expression.

Lower Risk

Aaron's LLC has not supported ideological causes or policies (1).



Uses corporate funds to advance ideological causes, organizations, or policies hostile to freedom High Risk of expression.

Aaron's was a Champion Tier corporate sponsor of the Trevor Project, an organization that advocates for controversial sex and gender ideology, including "gender transition" drugs and surgeries for minors, through legislation, litigation, advertising, and PR campaigns. The organization also hosts online chatrooms that allow adults to communicate with minors as young as 13 about sexually explicit topics. Adults in these chatrooms have encouraged minors to adopt transgender identities and withhold this information from their parents (1)(2)(3)(4)(5). Aaron's LLC has made contributions to Lost-n-found Youth, an LGBTQ organization working with youth (6). Otherwise, there are no publicly known cases of Aaron's LLC using corporate funds to advance ideological causes, organizations, or policies (7).

Uses corporate political actions and/or financial contributions for ideological, non-business purposes.

Aaron's has not used its PAC donations or lobbying for ideological purposes (1)(2)(3).
