DESCRIPTION:

Love's, a travel stop store, does not publish a nondiscrimination policy. However, it has not publicly terminated business relationships based on views or beliefs. Love's has donated to the Urban League of Greater Oklahoma City and discriminates against religious organizations in its charitable giving. However, the company has not used its reputation to advance ideological purposes. For these reasons, Love's receives a Medium Risk rating.
