



# Haleon

### **DESCRIPTION:**

Haleon is part of the Global Alliance for Responsible Media and vets vendors for LGBTQ policies. However, the company has not publicly terminated business relationships based on views or beliefs. Haleon conducts annual D&I training, including unconscious bias training, for all its employees. Haleon has lobbied for the Equality Act and the Respect for Marriage Act, which restricted religious freedoms. However, the company does not discriminate against charitable organizations based on views or beliefs. For these reasons, Haleon receives a Medium Risk rating.

## **Corporate Weaponization**

Has denied service to customers, suppliers, or vendors due to their political views or religious Medium Risk beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries.

<u>1)(2)(3)</u>. Haleon has a written policy pledging to vet vendors for LGBTQ policies. Its Code of Conduct applies to all suppliers and includes a commitment to not discriminate on the basis of sexual orientation (<u>4</u>). The company has not publicly fired customers, suppliers, or vendors based on political views or religious beliefs.

Charitable giving (including employee matching programs) policies or practices discriminate Lower Risk against charitable organizations based on views or religious beliefs.

Haleon does not discriminate against charitable organizations based on views or beliefs. The company focuses on funding "health literacy, healthcare accessibility and bias and prejudice" (<u>1</u>).

Employment policies fail to protect against discrimination based on political affiliation/views Medium Risk and/or religion.

Haleon implemented annual D&I training, including unconscious bias, training for all its employees (<u>1</u>). Haleon protects its employees against viewpoint discrimination (<u>2</u>).

In 2022, Haleon lobbied for the Equality Act. It also has lobbied for the Respect for Marriage Act, which restricted religious freedoms ( <u>1</u>). Haleon has donated to the Equality PAC (<u>2</u>)(<u>3</u>).
