A Subway franchise owner in North Carolina has been accused of illegal racially discriminatory hiring practices by the EEOC. The lawsuit is ongoing. This trial does not affect or blame Subway's corporate policies (1). Subway has not publicly canceled customers, suppliers, or vendors based on political views or religious beliefs (2).

Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs. Lower Risk

Subway does not appear to discriminate against charitable organizations based on views or beliefs (1)(2).

Employment policies fail to protect against viewpoint or other discrimination and/or are ideological in nature. Medium Risk

Subway does not publish a nondiscrimination policy (1).
