DESCRIPTION:

Moe's Southwest Grill has not publicly terminated business relationships based on views or beliefs. The company does not protect its employees against viewpoint discrimination and has donated to the Purdue LGBTQ center. Moe's publicly advocated for the BLM community on its social media but has not used its corporate reputation to advance ideological agendas. The company does not discriminate against charitable organizations based on views or beliefs. For these reasons, Moe's Southwest Grill receives a Lower Risk rating.
