## **DESCRIPTION:**

Lockton often yields to political activism in shaping corporate governance, potentially alienating consumers, dividing employees, and harming shareholders. The company implements race and identity-based policies that replace merit, excellence, and integrity with preferential treatment and outcomes. Lockton occasionally embraces corporate initiatives that redirect its central focus from business goals to partisan policies and divisive issues at times. This approach fails to safeguard free exercise, free speech, and free enterprise.

Has canceled customers, suppliers, or vendors due to their political views or religious beliefs OR Lower Risk corporately boycotts, divests, or sanctions regions, people groups, or industries.

Lockton has not publicly canceled customers, suppliers, or vendors based on political views or religious beliefs (1).

Lockton is an executive member of the LGBTQ Mid-America Chamber of Commerce and hosted a virtual Diversity & Inclusion learning series ( $\underline{1}$ )( $\underline{2}$ ). The company's former CEO, Peter Clune III, signed the CEO Action for Diversity & Inclusion pledge, which includes a commitment to promote DEI through bias education training in the workplace ( $\underline{3}$ )( $\underline{4}$ ). Otherwise, there are no publicly known cases of Lockton using its reputation to advance ideological causes or policies ( $\underline{5}$ ).

Lockton partners with LINK, an LGBTQ+ insurance network (1). The company is a Corporate Member of the Mid-America LGBT Chamber of Commerce (2)(3). Otherwise, there are no publicly known cases of Lockton using corporate funds to advance ideological causes, organizations, or policies (4).

Uses corporate political actions and/or financial contributions for ideological, non-business Lower Risk purposes.

Lockton has not used its PAC donations for ideological purposes and has not reported on its lobbying at this time (1)(2)(3).
