DESCRIPTION:

AVANGRID Inc., which is an energy company, does not protect its employees against viewpoint discrimination but has not publicly terminated business relationships based on views or beliefs. The company's CEO signed the CEO Action for Diversity and Inclusion pledge and regularly supports LGBTQ Pride. AVANGRID funds the New Haven Pride Center and embraces UN Sustainable Development Goals as part of its giving program. However, the company does not appear to discriminate against charitable organizations based on views or beliefs and has not used its political contributions for ideological purposes. For these reasons, AVANGRID Inc. receives a Medium Risk rating.
