

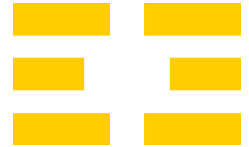

DESCRIPTION:

Tinker Federal Credit Union often yields to political activism in shaping corporate governance, potentially alienating consumers, dividing employees, and harming shareholders. The company elevates merit, excellence, and integrity ahead of race and identity-based policies. Tinker Federal Credit Union occasionally embraces corporate initiatives that redirect its central focus from business goals to partisan policies and divisive issues at times. This approach fails to safeguard free exercise, free speech, and free enterprise.

Corporate Weaponization

Has canceled customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries. Medium Risk

Tinker Federal Credit Union placed an employee on administrative leave following "offensive comments" related to the death of George Floyd on her private Facebook account ([1](#)). It is unclear whether the employee returned back to Tinker Federal Credit Union. However, Tinker Federal Credit Union has not canceled customers, suppliers, or vendors based on political views or religious beliefs ([2](#)).

Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs. Lower Risk

Tinker Federal Credit Union does not appear to discriminate against charitable organizations based on views or beliefs ([1](#))([2](#)).

Employment policies fail to protect against viewpoint or other discrimination and/or are ideological in nature. Lower Risk

Tinker Federal Credit Union protects its employees against viewpoint discrimination ([1](#)).

Corporate Governance and Public Policy

Uses corporate reputation to support causes, organizations, or policies hostile to freedom of expression. Lower Risk

Tinker Federal Credit Union has not supported ideological causes or policies ([1](#)).

Uses corporate funds to advance ideological causes, organizations, or policies hostile to freedom of expression. Lower Risk

Tinker Federal Credit Union has not used corporate funds to advance ideological causes, organizations, or policies ([1](#)).
