## **DESCRIPTION:**

ZF North America does not yield to political activism in shaping corporate governance, preventing initiatives that potentially alienate consumers, divide employees, and harm shareholders. The company implements race and identity-based policies that replace merit, excellence, and integrity with preferential treatment and outcomes. Overall, ZF does not embrace corporate initiatives that redirect its central focus from business goals to partisan policies and divisive issues. This approach protects free exercise, free speech, and free enterprise.

## **Corporate Weaponization**

Has canceled customers, suppliers, or vendors due to their political views or religious beliefs OR Lower Risk corporately boycotts, divests, or sanctions regions, people groups, or industries.

ZF Friedrichshafen has not publicly canceled customers, suppliers, or vendors based on political views or religious beliefs (1).

Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs.

ZF does not discriminate against charitable organizations based on views or beliefs (1).

ZF is a member of the German Diversity Charter which has a goal of keeping "staff informed about the value of diversity and [involving] them in implementing the Charter" (1)(2). ZF scored a 30 out of 100 on the 2023-2024 Corporate Equality Index (CEI) from the Human Rights Campaign (HRC), a political stakeholder group (3)(4).

ZF North America is a Brass sponsor of Out & Equal, an LGBTQ organization (1). Otherwise, there are no publicly known cases of ZF using corporate funds to advance ideological causes, organizations, or policies (2).
