DESCRIPTION:

Wolters Kluwer, which is a publishing company, vets vendors according to LGBTQ policies but has not publicly terminated business relationships based on views or beliefs. Wolters Kluwer regularly supports LGBTQ Pride and supports ESG within its business practices. However, the company has not used corporate funds or lobbied for ideological purposes. Wolters Kluwer protects its employees against viewpoint discrimination. For these reasons, Wolters Kluwer receives a Lower Risk rating.

Corporate Weaponization

Has denied service to customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries. **Medium Risk**

Wolters Kluwer has a written policy pledging to vet vendors for LGBTQ policies. Its Code of Conduct applies to all suppliers and includes a commitment to not discriminate on the basis of sexual orientation (1). However, the company has not publicly fired customers, suppliers, or vendors based on political views or religious beliefs.

Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs. **Lower Risk**

Wolters Kluwer does not appear to discriminate against charitable organizations based on views or beliefs (1).

Employment policies fail to protect against discrimination based on political affiliation/views and/or religion. **Lower Risk**

Wolters Kluwer protects its employees against viewpoint discrimination (1).

Corporate Governance and Public Policy

Uses corporate reputation to support ideological causes and/or organizations hostile to freedom of expression. **Medium Risk**
