## DESCRIPTION:

Dollar Bank does not provide viewpoint protections for its employees but has not publicly terminated business relationships based on views or beliefs. The company uses its reputation to promote LGBT pride and its CEO signed the CEO Action for Diversity & Inclusion pledge. However, it has not used its corporate dollars or PAC contributions for ideological purposes. For these reasons, Dollar Bank receives a Lower Risk rating.
