The Geo Group, Inc., is Lower Risk. The company does not yield to political activism in shaping corporate governance, preventing initiatives that potentially alienate consumers, divide employees, and harm shareholders. The company implements race and identity-based policies that replace merit, excellence, and integrity with preferential treatment and outcomes. Overall, The Geo Group does not embrace corporate initiatives that redirect its central focus from business goals to partisan policies and divisive issues. This approach protects free exercise, free speech, and free enterprise.

From its Human Rights and ESG Report 2022: "Minorities comprise 45% of GEO's corporate workforce in the U.S., 73% of our facility security staff, and 33% of those serving in management positions as directors or above" (2). The Geo Group offers diversity training to its employees (3). The company does not provide viewpoint protections for its employees (4).*

*The Geo Group supports ESG within its business practices, "look[ing] forward to continued engagement with our diverse stakeholders as we pursue our ESG goals and aspirations" (1).
