This approach protects free exercise, free speech, and free enterprise.

### **Corporate Weaponization**

Has canceled customers, suppliers, or vendors due to their political views or religious beliefs OR Lower Risk corporately boycotts, divests, or sanctions regions, people groups, or industries.

The Whiting-Turner Contracting Company has not publicly canceled customers, suppliers, or vendors based on political views or religious beliefs (1)(2).

Charitable giving (including employee matching programs) policies or practices discriminate Lower Risk against charitable organizations based on views or religious beliefs.

The Whiting-Turner Contracting Company does not publish charitable giving guidelines but does not appear to discriminate against charitable organizations based on views or beliefs. They partner with Habitat for Humanity, a faith-based organization ( $\underline{1}$ ).

The Whiting-Turner Contracting Company likely protects its employees against viewpoint discrimination. The company values a variety of "viewpoints" and "strongly value[s] the variation of backgrounds, perspectives and beliefs held by [its] employees" (<u>1</u>).
