DESCRIPTION:

Trinseo does not yield to political activism in shaping corporate governance, preventing initiatives that potentially alienate consumers, divide employees, and harm shareholders. The company implements race and identity-based policies that replace merit, excellence, and integrity with preferential treatment and outcomes. Overall, Trinseo does not embrace corporate initiatives that redirect its central focus from business goals to partisan policies and divisive issues. This approach protects free exercise, free speech, and free enterprise.

Corporate Weaponization

Has canceled customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries. Medium Risk

Trinseo PLC has not publicly canceled customers, suppliers, or vendors based on political views or religious beliefs. Trinseo integrates ESG-related interests into all of its business practices. It centers its processes around the "Environment, Economic, and Social (EES) impact on [its] employees, communities, customers, partners, and other stakeholders" indicating participation in stakeholder capitalism (1).

Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs. Lower Risk

Trinseo PLC does not appear to discriminate against charitable organizations based on views or beliefs. The company gives to organizations that contribute to the local economy, community development, science education, and workplace safety (1).
