## DESCRIPTION:

TTM Technologies does not yield to political activism in shaping corporate governance, preventing initiatives that potentially alienate consumers, divide employees, and harm shareholders. The company elevates merit, excellence, and integrity ahead of race and identity-based policies. TTM Technologies does not embrace corporate initiatives that redirect its central focus from business goals to partisan policies and divisive issues. This approach protects free exercise, free speech, and free enterprise.

### Corporate Weaponization

**Has canceled customers, suppliers, or vendors due to their political views or religious beliefs OR corporately boycotts, divests, or sanctions regions, people groups, or industries. Medium Risk**

*TTM Technologies has not publicly canceled customers, suppliers, or vendors based on political views or religious beliefs. TTM Technologies integrates ESG into all of its business practices claiming commitment to keeping “stakeholders engaged by maintaining strong environmental, social, and governance practices” (1).*

**Charitable giving (including employee matching programs) policies or practices discriminate against charitable organizations based on views or religious beliefs. Lower Risk**

*TTM Technologies does not appear to discriminate against charitable organizations based on views or beliefs. TTM offers “charitable contributions and the personal commitment of our employees through initiatives that span volunteer work at non-profits, projects that support the environment, educational support, and philanthropic giving” (1).*

**Employment policies fail to protect against viewpoint or other discrimination and/or are ideological in nature. Medium Risk**

*TTM Technologies does not provide viewpoint protections for its employees (1).*

*TTM Technologies has not supported ideological causes or policies (1).*
