Acco Brands Corporation, a designer and manufacturer of academic, consumer, and business products, vets vendors for LGBTQ policies and does not provide viewpoint protections for its employees. However, it has not publicly terminated business relationships based on views or beliefs. Acco Brands Corporation partnered with Jazz Jennings, a transgender person, and made charitable donations through that partnership. However, the company does not appear to discriminate against religious organizations in its charitable giving and has not used its reputation for ideological purposes. For these reasons, Acco Brands receives a Lower Risk rating.

Corporate Weaponization

Acco Brands has a written policy pledging to vet vendors for LGBTQ policies. Its Code of Conduct requires vendors to include sexual orientation and gender identity in its nondiscrimination policy¹.
