Acushnet Holdings Corp, a golf clothing, equipment, and accessories manufacturer, vets vendors for LGBTQ policies and does not provide viewpoint protections for its employees. However, it has not publicly terminated business relationships based on views or beliefs. The company has not used its corporate reputation or funds for ideological purposes. For these reasons, Acushnet receives a Lower Risk rating.

Acushnet Holdings has a written policy pledging to vet vendors for LGBTQ policies. Its company supplier citizenship policy requires vendors to include sexual orientation in its nondiscrimination policy (1).
