DESCRIPTION:

Sentara Healthcare (Sentara) is Medium Risk. The company often yields to political activism in shaping corporate governance, potentially alienating consumers, dividing employees, and harming shareholders. The company implements race and identity-based policies that replace merit, excellence, and integrity with preferential treatment and outcomes. Sentara occasionally embraces corporate initiatives that redirect its central focus from business goals to partisan policies and divisive issues at times. This approach fails to safeguard free exercise, free speech, and free enterprise.

Corporate Weaponization

Has canceled customers, suppliers, or vendors due to their political views or religious beliefs OR Lower Risk corporately boycotts, divests, or sanctions regions, people groups, or industries.

Sentara has not publicly canceled customers, suppliers, or vendors based on political views or religious beliefs (1).

Charitable giving (including employee matching programs) policies or practices discriminate Lower Risk against charitable organizations based on views or religious beliefs.

Sentara does not appear to discriminate against charitable organizations based on views or beliefs. The company's charitable giving focuses on addressing "social determinants of health", fostering "equitable health", and addressing "health disparities magnified by the impact of COVID-19 on underserved populations" (1)(2).

Employment policies fail to protect against viewpoint or other discrimination and/or are ideological in nature.

High Risk

Sentara offers unconscious bias and DEI training to its employees (1). Sentara does not publish a nondiscrimination policy (2).

Corporate Governance and Public Policy

Uses corporate reputation to support causes, organizations, or policies hostile to freedom of expression.

In 2022, Sentara hosted a webinar titled "Transgender & Non-Binary Experiences with Healthcare" (1). Sentara supports DEI within its business practices, employing a Chief Diversity Officer (2). It also hosts a Center for Diversity, Inclusion & Cultural Competency (3)



). Otherwise, there are no publicly known cases of Sentara using its reputation to advance ideological causes or policies (4).

Uses corporate funds to advance ideological causes, organizations, or policies hostile to freedom High Risk of expression.

All 12 Sentara hospitals were acknowledged as leaders in LGBTQ+ healthcare by the 2020 Healthcare Equality Index (1). This indicates, among other things, the medical centers "offer transgender-inclusive healthcare benefits to their employees", which includes coverage for hormone replacement therapy, puberty blockers, and gender reassignment surgeries for employees and their children (2). Sentara has supported the YWCA (3)(4). Otherwise, there are no publicly known cases of Sentara using corporate funds to advance ideological causes, organizations, or policies (5).

Uses corporate political actions and/or financial contributions for ideological, non-business purposes.
