## DESCRIPTION:

Its charitable giving focuses on "giving back to local communities through advancing education and STEM initiatives, promoting equality of opportunities and engaging employees in supporting the company's commitment to making a difference" (1).*

**Employment policies fail to protect against viewpoint or other discrimination and/or are ideological in nature.** Medium Risk

*Allison Transmission does not provide viewpoint protections for its employees (1).*

*In 2022, Allison Transmission hosted a food drive in celebration of Pride Month (1). Otherwise, it has not supported ideological causes or policies (2).*

*Allison Transmission has not used corporate funds to advance ideological causes, organizations, or policies (1).*
